- 5. Live Foal Guaranteed. Live foal means the foal shall stand and nurse. It is understood that if the mare proves to be barren, aborts, or if the foal is still-born, a season will be guaranteed the following year only providing proper notification is given. Proper notification shall be defined as follows: Written certification from A LICENSED VET WITHIN 7 DAYS THAT THE MARE HAS SLIPPED OR PRODUCED A NON-VIABLE FOAL. Mare Owner certifies that such abortion or death did not result from any omission of the Owner to the mare's departure from O'Donnell Horses Unlimited. BOOSTER RHINO MUST BE ADMINISTERED AS INDICATED BY THE DRUG MANUFACTURER AS THE MARE PROCEEDS THROUGH HER PREGNANCY. FAILURE TO DO SO, WILL VOID THEIR LIVE FOAL GUARANTEE. Rebreed privileges extended beyond the following year are subject to an additional fee.
- 6. Color Guarantee. A colored foal means the resulting foal will qualify for regular registration papers from the Appaloosa Horse Club.
- 7. The breeding season in force for this contract shall begin February 15 and closes June 15 of the year covered in this contract. No new mares will be accepted for breeding after June 1 unless special arrangements are agreed upon by both parties.
- 8. It is further agreed that should the above named stallion die or become unfit for service, or, if the above named mare should die, during the breeding season, then the Mare Owner may substitute another mare or breed another stallion at the ranch that is agreed upon by both parties.
- 9. A Breeder's Certificate will be issued to the Owner of the mare after the time of breeding, after all expenses have been paid in full and upon notification of the birth of the foal.
